Afghans in the neighboring countries

Iran

- Over 2 million Afghans targeted for deportation by March 2025
- At least 250,000 Afghans detained in 2024
- Intensifying negative public sentiments and discrimination for Afghans
- Afghans banned from residing in 16 provinces
- Restricted access to education, healthcare, and housing
- Barriers to livelihoods increasing labor exploitation and child protection risks

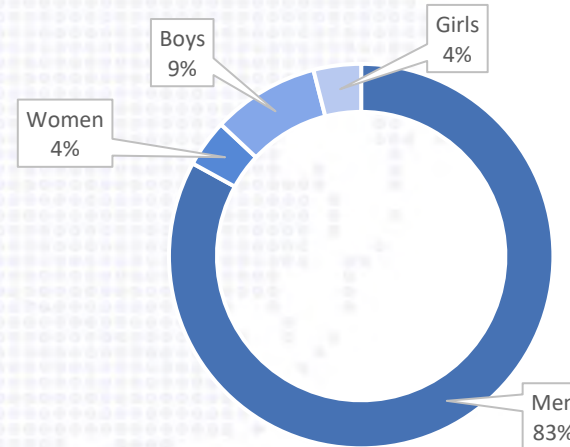
Pakistan

- April 2025 IFRP 2nd Phase targeting undocumented individuals and ACC holders
- 28,000 Afghan nationals arrested and detained since 1 Jan 2025
- Detention in holding sites with poor conditions
- Lack of due process
- Limiting movements within the country
- Spontaneous returns driven by fear of arrest
- Increased cases of family separation

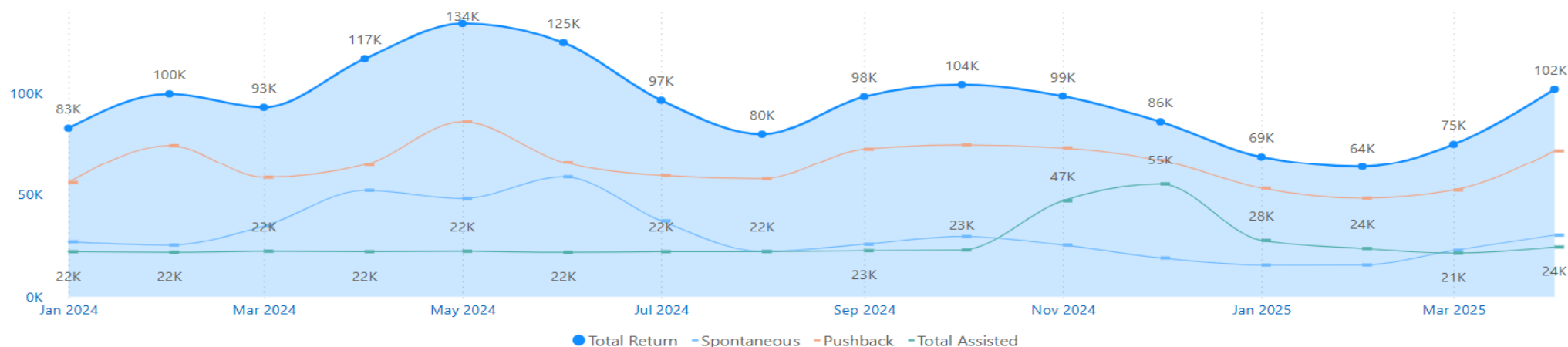
Undocumented Returns from Iran (1 Jan 2024-7 May 2025)

- IOM AFG recorded more than **1.5 million** undocumented Afghan migrant returns.
- **68%** expulsions and **32%** spontaneous returns.
- **85%** single travelers and **15%** families.

Sex and Age Breakdown



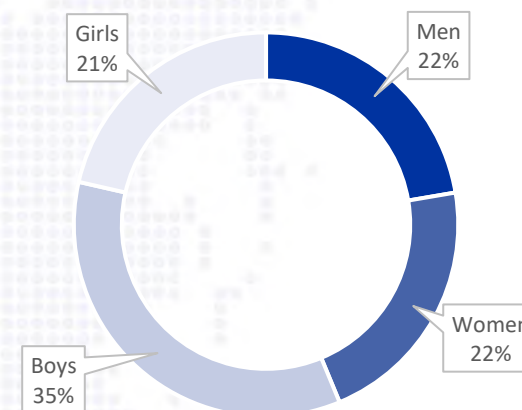
Undocumented Return to Afghanistan Over Time



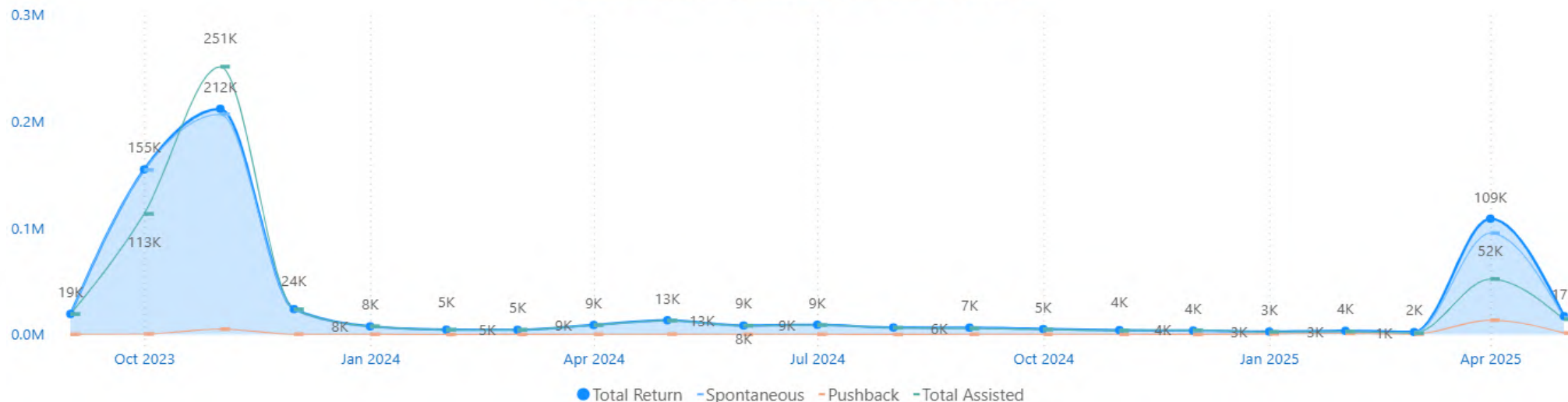
Undocumented Returns from Pakistan (Sep 2023-7 May 2025)

- IOM AFG recorded more than **626,000** undocumented Afghan migrant returns (including ACC holders).
- **4%** expulsions and **96%** spontaneous returns.
- **98%** families and **2%** single travelers.

Sex and Age Breakdown

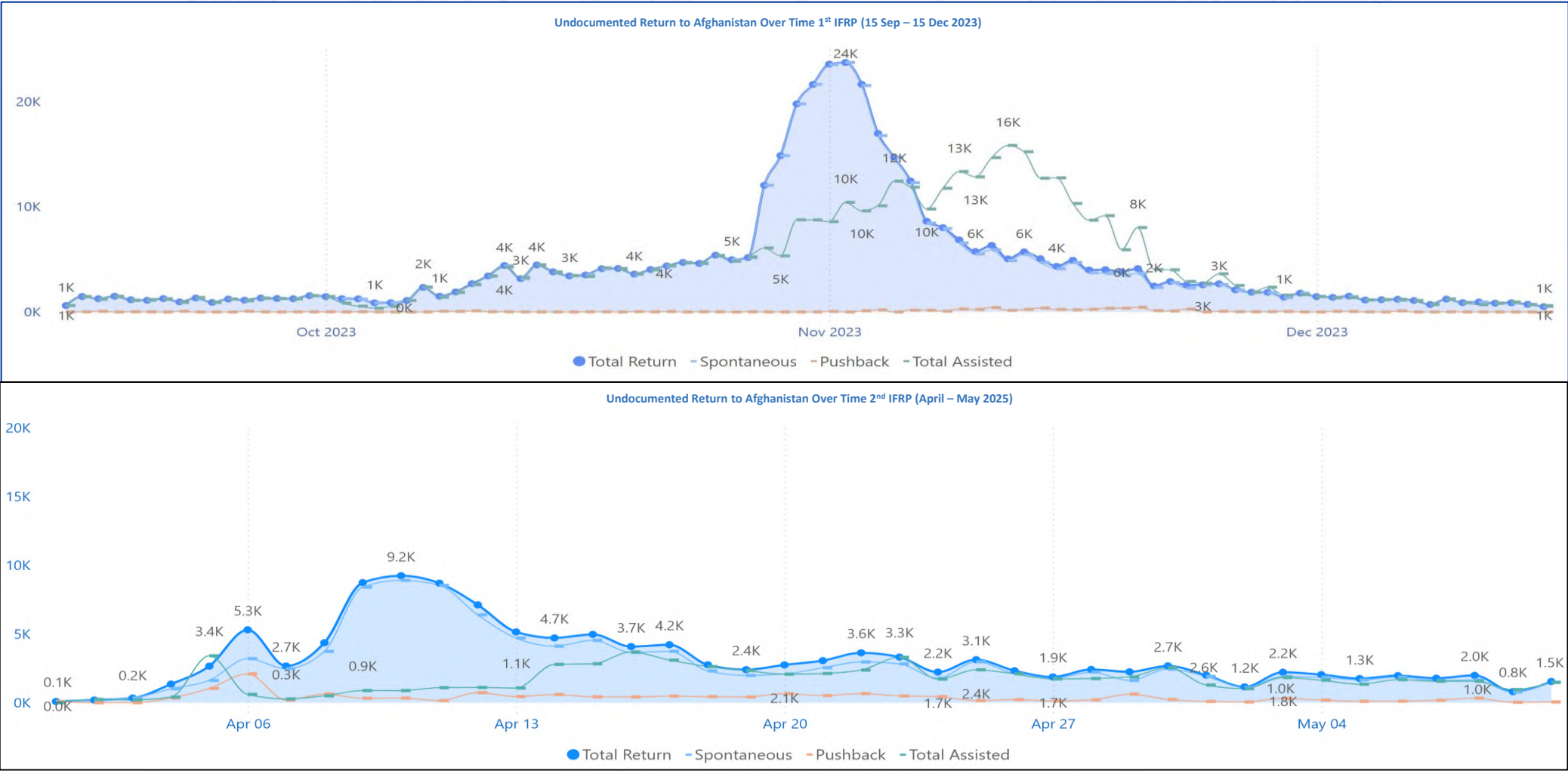


Undocumented Return to Afghanistan Over Time



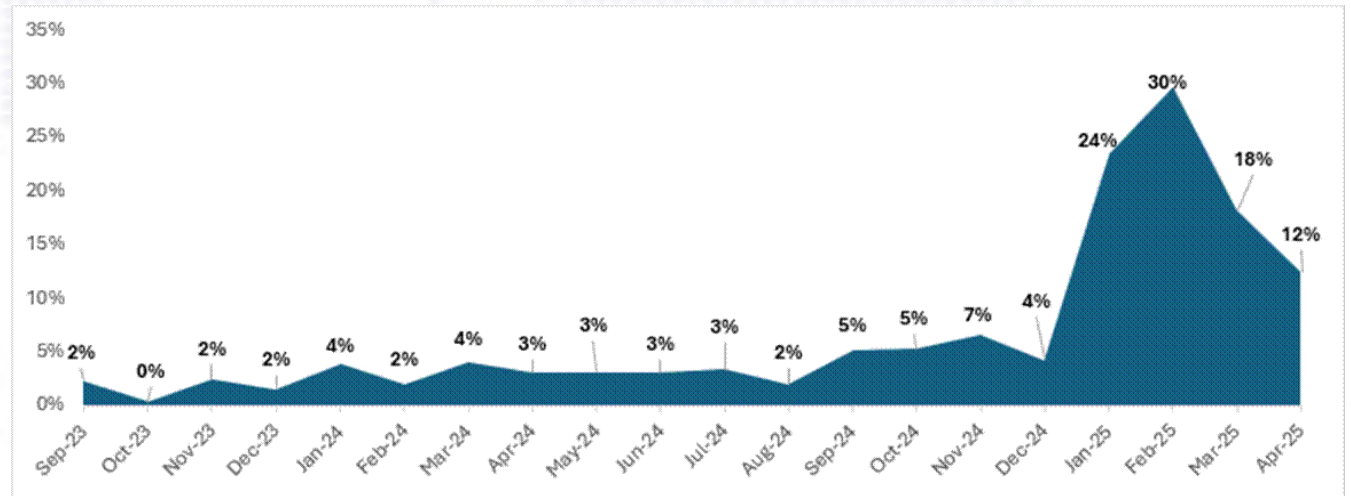
Return Trends from Pakistan IFRP 1 vs. IFRP 2

(Different Timeframe)

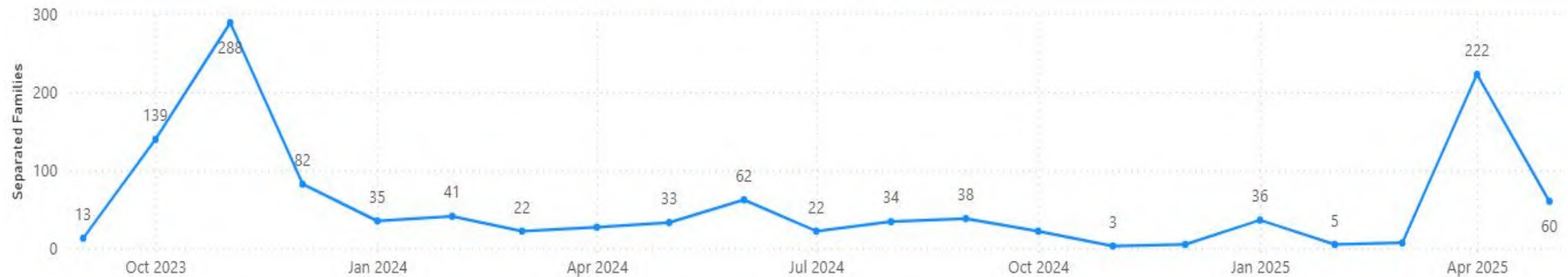


Expulsions and Separated Families

-IFRP 1 vs. IFRP 2



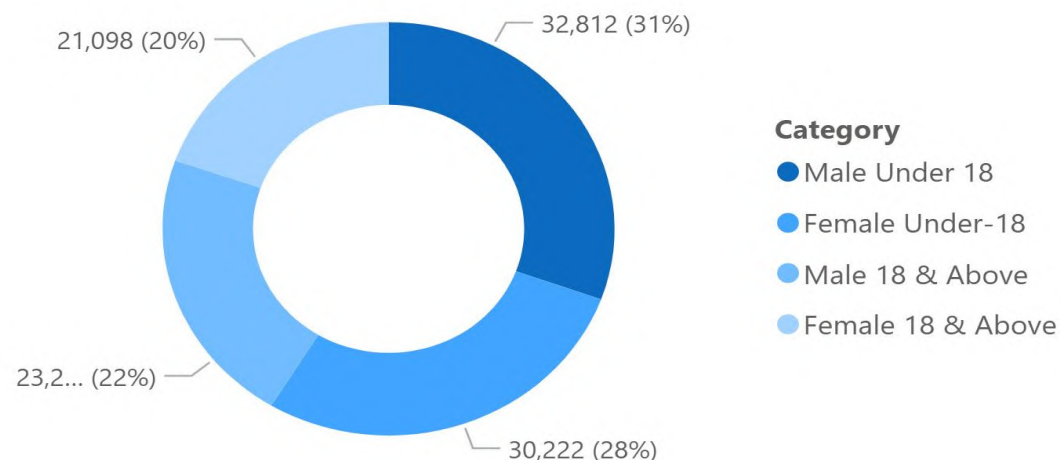
PSN by Number of Cases



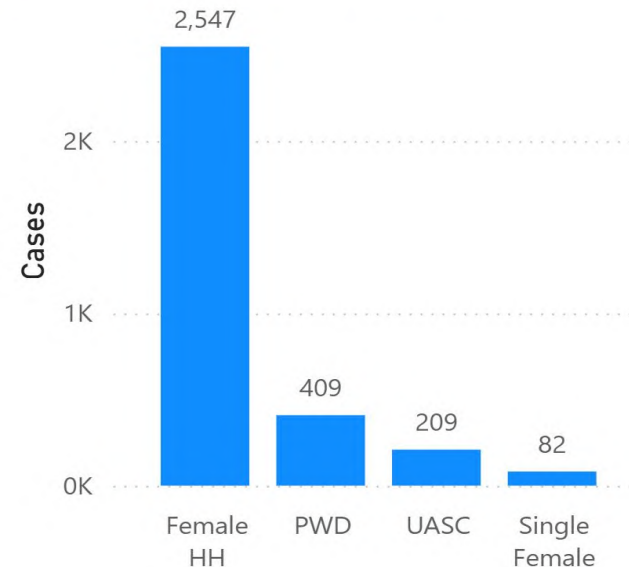

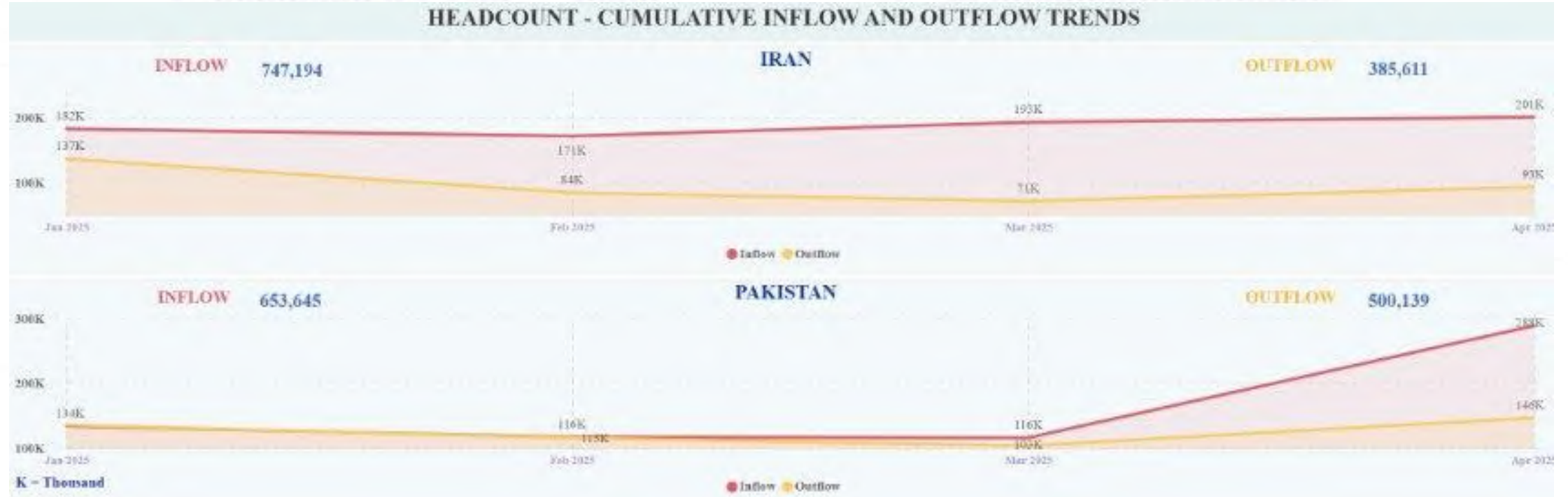

Top Main Reasons For Departures To Iran

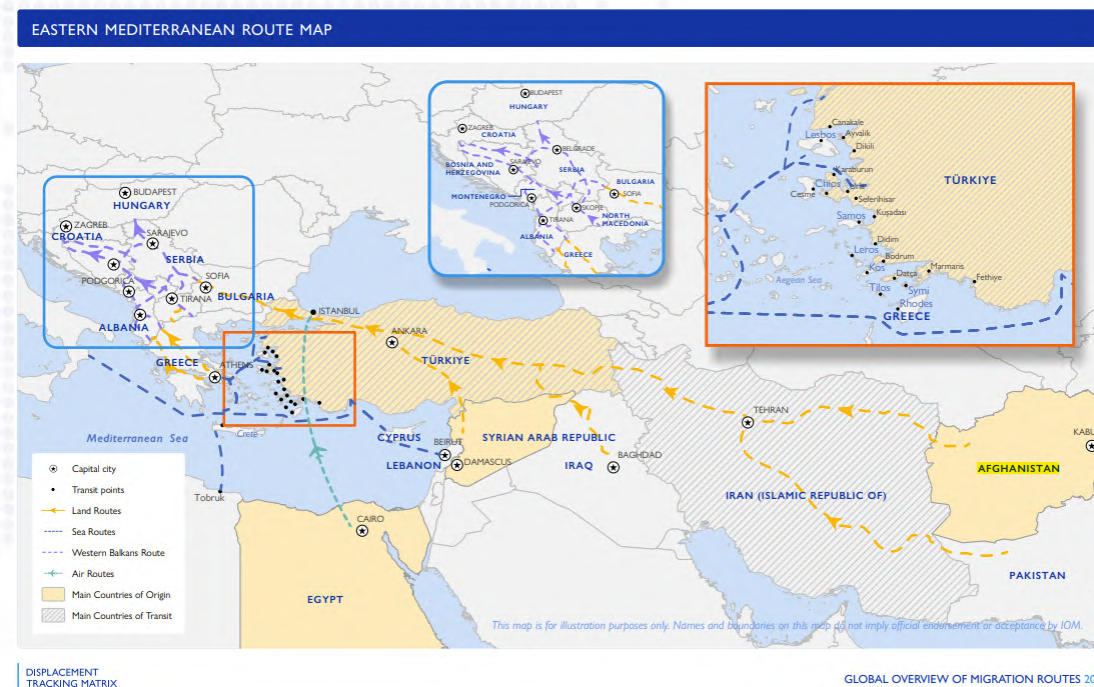


Top Main Reasons For Departures To Pakistan



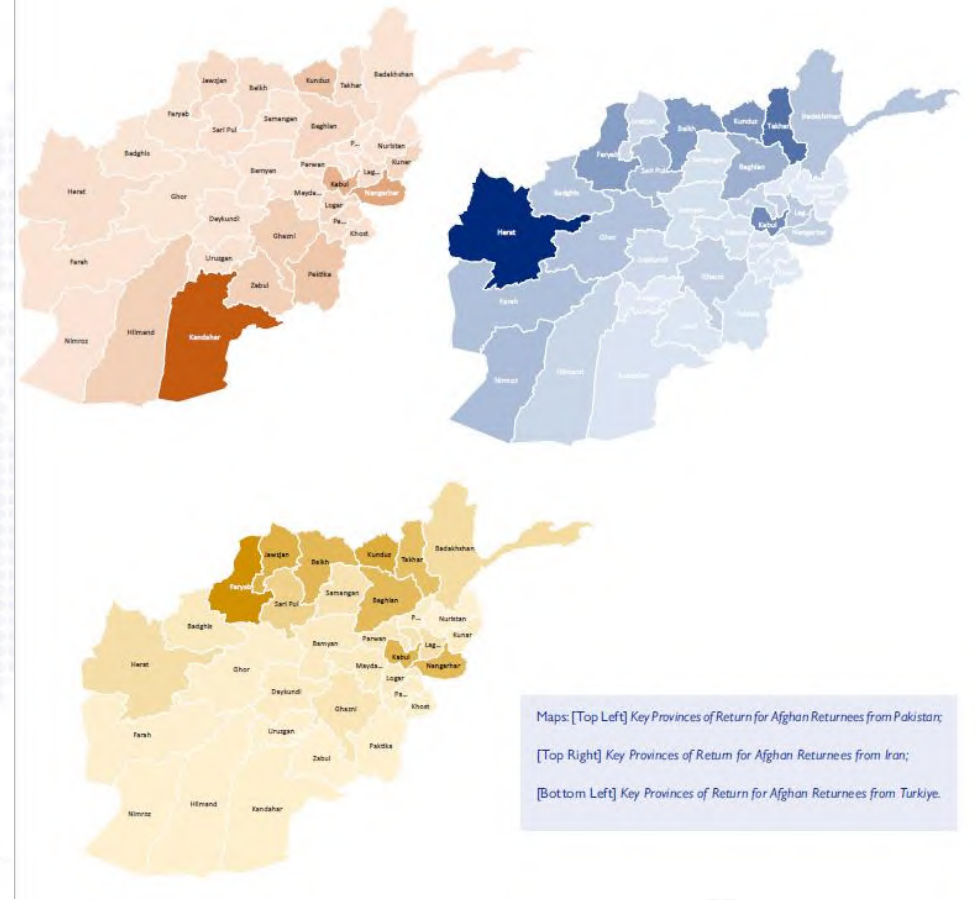
Returns from Turkey

- About **40,000** undocumented Afghan migrant returns since Oct 2023.
- **96%** expulsions and **4%** spontaneous returns.
- **97%** single travelers and **3%** families.
- Majority are individual males (18-30 years)
- Turkey remains a key gateway to Europe
- Lack of legal status and documentation
- High unemployment and reliance on daily labor
- Reports of detentions and abusive conditions



Challenges upon Return

- Further straining fragile areas of returns already burdened by existing returnees, IDPs, host communities and new IDPs (climate impacts)
- Lack of civil documentation and livelihood opportunities
- Inadequate shelter, access to education and health-care services
- Social exclusion and discrimination
- Negative coping mechanisms often leading to cycles of debt
- Heightened risks for women and girls

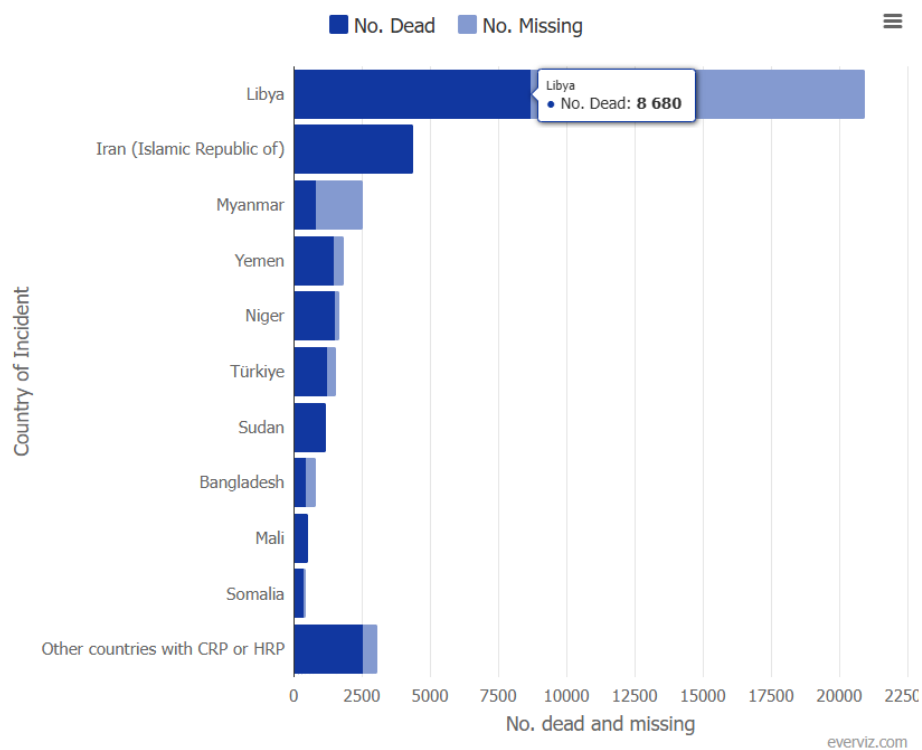


Negative Cycle of Migration

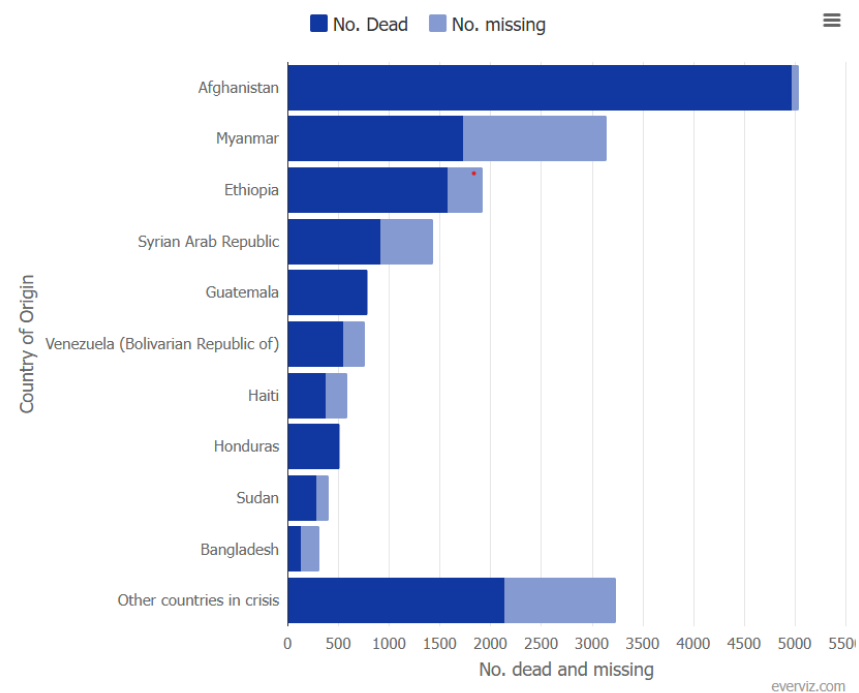
- Drivers of migration – social, economic, political and safety-related push and pull factors
- Challenging socio-economic reintegration environment
- Negative coping mechanisms
- Secondary displacement including climate change-induced displacement
- Limited regular pathways and high associated costs and time-consuming process for regular migration
- Available irregular channels

Top 10 countries of origin of missing migrants fleeing crisis,

Note: the majority of deceased persons recorded by MMP lack data on country of origin. The identities of these tens of thousands of people remains unknown.

Actions for Durable Solutions

- In neighboring countries:
 - Expansion and simplification of regularization schemes
 - Expansion of regular pathways
 - Promote complementary pathways
 - Advocacy for voluntary return process and against expulsions and deportations
- In Afghanistan:
 - Support across the spectrum of mobility
 - Continued advocacy for women and girls:
 - Engagement with the DfA
 - Strengthening local ownership
 - Monitoring progress towards durable solutions
