# a) Migration Missions

**HU** and the **Commission representative** provided information on the outcome of the Migration Mission to Azerbaijan, held on 16-17 June 2011 in Baku, the report of which is set out in 12236/11 ASIM 73 RELEX 721 COEST 238 (RESTREINT UE/RESTRICTED UE).

# b) Mobility Partnerships

The **Commission representative** provided information on the state of play of existing (Cape Verde, Moldova and Georgia) and planned (Armenia, Ghana) Mobility Partnerships.

#### c) Rabat-Paris Process

**ES** and **FR** provided information on the developments in relation to the Rabat-Paris process in view of the third Euro-African Ministerial Conference on Migration and Development, which is expected to take place in November 2011.

The **Chair** informed that this item will be included in the agenda of the next HLWG meeting.

# 4. Building Migration Partnerships

**HU** provided information on the outcome of the Senior Officials Meeting (SOM) held in Budapest on 30-31 May 2011.

The **Chair** informed the Group that it will submit at the September HLWG meeting for consideration a new version of the draft Action Plan, as revised following the Budapest SOM, in view of the forthcoming Senior Official Meeting (to which all the partners of the Prague process will take part). The next SOM is expected to take place in September/October.

The **Commission representative** provided information on the outcome of the EU-ACP Joint Ministerial Council held in Brussels on 31 May 2011, where it was agreed to pursue the dialogue on migration already established between the two sides. Noting that contacts are ongoing with the ACP side in order to consider how this dialogue could be developed, he said that he information on progress in this area will be provided at the next HLWG meeting.

Welcoming the successful launch of the EU-Russia dialogue on migration, the **Group** had an exchange of views on future steps in this area.

# 10. Situation in the Southern Mediterranean Region

The **Chair** and the **Commission representative** provided information on the outcome of the European Council of 23-24 June (the Conclusions of which are set out in EUCO 23/11 CO EUR 14 CONCL 4) and of the JHA Council of 9-10 June 2011 (which adopted Conclusions on Borders, Migration and Asylum - Stocktaking and the way forward, as set out in 11476/11 ASIM 64 COMIX 395) in relation to migration issues.

The **Group** had an exchange of views on future steps to be taken in this area and in particular on the issue of the launch of dialogues on migration, mobility and security with the relevant countries in the Southern Mediterranean Region. In the framework of the discussion it was underlined that the Presidency and the Member States should be fully associated with the Commission and the European External Action Service in such dialogues.

# I. Home Affairs clauses in agreements

#### • Mongolia:

On December 20, a Partnership and Cooperation Agreement was established between Mongolia and the European Union (EU) in Ulaanbaatar, and the phase of talks was successfully concluded. The text following the Inter-Service Consultations was adopted by Commission decision on 14 March 2011.

#### • Vietnam:

The PCA EU-Vietnam was initialled in the margins of the ASEM Summit on October 4. The agreement might be signed during the second half of 2011.

#### Philippines:

The PCA agreement was signed by 26 EU MS by the end of February. The Council decision to sign the PCA EU-Philippines agreement on behalf of the EU should be adopted as quickly as possible in 2011. Subsequently, the agreement should be signed together with the Philippines.

#### • Australia:

- New Framework Agreement will be negotiated (and possibly concluded) in 2011, including standard migration clause. A mandate for negotiations will be requested soon.
- The EU-Australia PNR Agreement has been initialled and sent to Council and EP.

#### • Malaysia:

PCA negotiations with Malaysia were launched on 5 October 2010. A first negotiating round was held on 21/22 February 2011.

## • Singapore:

PCA negotiations started again in March 2011 following an interruption since May 2006.

#### II. Visa and readmission

• China: strategy regarding the future Chinese request for visa facilitation: COM encourages the Council to discuss the general approach towards a strategy on migration with China, with a particular focus on readmission and the Chinese request for visa facilitation. A PCA Steering Group will be organised in the autumn.

#### Sri Lanka:

Readmission agreement entered into force in 2005; meeting of the Joint Readmission Committee will take place before the end of the year 2011.

• **EU-Pakistan readmission agreement**: entered into force on 1 December 2010.

#### Belarus:

The negotiation mandate for the visa facilitation and readmission agreements with Belarus was adopted by the TTE Council on 28 February 2011. On 1 June Commission sent a letter to Belarus inviting them to start negotiations on visa facilitation and readmission agreements.

#### • Georgia:

The readmission and visa facilitation agreements were adopted by the Council on 18 January 2011. The VFA subsequently entered into force on 1 March. The Joint Readmission Committee has not been established yet. Both joint visa facilitation and readmission committees took place on 1 June 2011.

## • Republic of Moldova:

Visa dialogue: on-going

Visa facilitation: The Joint Committees on Visa Facilitation and Readmission Agreements met on 12 May in Brussels. Negotiations on amending the Visa Facilitation Agreement were launched on 12 May, in Brussels.

#### Russia:

- Visa dialogue: the text resulting from the last senior officials meeting held on 27 June in Moscow was transmitted to the MS (COEST). The next SOM is planned for 12 July.
- Visa facilitation: the draft mandate for renegotiation presented by the COM in the end of October was adopted by the JHA Council on 11-12 April. First negotiation round has taken place. Meeting of the Joint Committee monitoring the existing agreement took place on 27-28 April. Readmission: next Joint Readmission Committee meeting will take place in Brussels on 13 July 2011.

#### Ukraine:

- Visa dialogue: A SOM took place on 5 April.
- Visa facilitation: The Joint Committees on Visa Facilitation and Readmission Agreements met on 5 May in Brussels. Negotiations on amending the Visa Facilitation Agreement were launched on 6 May, in Brussels. A second round will take place on 11 July in Kyiv.
