## CALL FOR CONTRIBUTIONS ABOUT THE COMPARATIVE STUDY ON THE IMPLEMENTATION OF THE EU DIRECTIVE ON RECEPTION CONDITIONS FOR ASYLUM SEEKERS

The Odysseus Network has been selected through a call for tender by the European Commission to undertake, in closed partnership with the UNHCR and with the support of Fedasil coordinating the Network Enaro, the study on the implementation of the directive 2003/9 of 27 January 2003 laying down minimum standards for the reception conditions of asylum seekers. This study to be finished in October 2006 will cover the 23 Member States bound by the directive. It will focus on legal aspects in order to find out how Member States transposed the directive into national law, but also cover as much as possible practical aspects of reception conditions. A report for each Member State will be prepared by the rapporteurs of the Odysseus Network (see the list in annex to the message you received or on our website) for the end of June and a European synthesis for September. An open final conference will be organised on Tuesday 26 September in Brussels and the results in principle published in a book. Apart from the contacts which will be directly established by the national rapporteurs in each country in order to collect information on the practice, all interested NGO, reception centre or person can ask to receive the practical questionnaire and send it back to us once completed before the end of July. Relevant contributions will be reflected in the national reports and posted on our website if the submitter agrees. The questionnaire is in English, but answers can be drafted in the language of your Member State of origin. The national reports and the European synthesis only available in English or French will be made public for comments on our website respectively at the end of June and in September.

Please mention in particular if you are ready to complete the questionnaire on the practical aspects. You can also submit directly a statement about the implementation of the directive as well as proposals to improve it.
