The treaties of Rome 1957-2007

We just celebrated the 50th anniversary of the Treaties of Rome. 1957 was the beginning of a fascinating period that led to the European Union, a single currency, free movement of goods and capital and, partially, free movement of persons and services.

Those who favour the European unification process say that it allowed us to preserve peace in a continent that had only known wars. They point to the internal solidarity mechanisms that helped the poorer regions. Thanks to European help, they now have development and prosperity. The desire to link one's own wagon to the European locomotive is even said to have accelerated the transition form dictatorship to democracy in some countries. Constantly, we are reminded of the fact that the single European space and the single currency are creating more wealth...

Nevertheless...

This European happiness is not shared by all. How else should we explain the 'non' and 'neen' vote against the draft European constitutional treaty? Europe is perceived as a Brussels Moloch, business that cannot interest the ordinary man in the street. He/she does not know what is decided in Brussels and, at any rate, he/she has no voice. Working class people see the European Union and its internal market as a threat to social rights and public services, more than as a source of wealth and welfare. There is a feeling that 'Brussels' has too much power and that decisions are not taken at the adequate level.

Nevertheless ...

Europe is constantly presented as a project of peace, of international cooperation, of solidarity and prosperity. These are the values of the left, whereas the left does not love Europe...

Why?

This international conference of Masereelfonds, Vrede (peace movement) and Imavo (Institute for Marxist Research) will try to find the answers to these questions. Why does the left not like this Europe?
