Although information held by the Review Team is not covered by the Freedom of Information Act we intend to operate a voluntary access scheme in keeping with the FOIA, and please be aware that the majority of the Review's information will be handed over to the Ministry of Justice for long-term preservation at the close of the Review, and the Ministry is covered by the FOIA.
