## **ANNEX**

- 1) The following will be included in the list of articles forbidden by point 4.1.1.1 of the annex to Regulation (EC) No. 622/2003:
- f) liquids, unless they are introduced in individual containers with a capacity of no more than 100 ml. contained, in turn, in a transparent plastic bag with an opening/closing system and with a capacity of no more than 1 litre. The contents of this bag will have to comfortably fit inside it and it will have to be possible for the bag to be closed completely. The liquids include gel, pastes, lotions, solid/liquid mixes, and the contents of pressurised containers, for example, toothpaste, hair gel, drinks, soups, syrups, perfume, shaving foam, aerosols and other articles of similar consistency.

Exemptions will be allowed if the liquid is:

- i) to be used during the flight and is either used for medical reasons or due to the requirements of special diets, including children's meals. When required to do so, the passenger will have to demonstrate the authenticity of the exempted liquid; or
- ii) obtained on the airside once the document check has been passed, proceeding from shops subject to security procedures that have been approved as part of the airport security programme, or
- iv) obtained from another EU airport, on condition that the liquid is packaged in a bag in which it will be obvious whether it has been handled and, moreover, it is possible to display proof of purchase on the airside of the airport and on the same day, or
- v) obtained on board an aircraft of an EU company, on condition that the liquid is packaged in a bag in which it will be obvious whether it has been handled and, moreover, it is possible to display proof of purchase on board of that aircraft on that day.
- g) individual pieces of hand luggage measuring more than 56 cm. x 45 cm. x 25 cm. The measurements will have to include handles, straps, pockets, wheels and other articles that protrude, including the contents of the suitcase/bag.

Exemptions will be applied for hand luggage of larger measurements that contain some article/articles that are larger and would not fit into a suitcase of the size that is allowed and are fragile or of considerable value. This luggage of a larger size will have to be presented by the passenger at check-in for approval and at the security check for inspection. This luggage of a larger size will have to be inspected, at least manually.

This g) section will be applied starting from six months after this Regulation has come into force.

- 2) The following will have to be included in the Annex to Regulation (EC) No. 622/2003:
- 4.1.1.8 Wheelchairs and baby carts used by passengers will be allowed to access the restricted security area, if and when they have been duly inspected.
- 4.3.1 All the liquids will have to be presented for inspection at the security check.
- 4.3.2 Portable computers and other large electrical articles will have to be extracted from the hand luggage prior to inspection and be separately inspected.
- 4.3.3 Passengers' coats and jackets will have to be inspected as if they were a separate piece of hand luggage.
- 3) Point 4.1.1.3 of the Annex to the Regulation (EC) No. 622/2003 will have to be replaced by the following:
- 4.1.1.3 The list of forbidden articles in section 4.1.1.1 and the information concerning allowed exemptions will have to be made available to the public.
