Subject:	Draft Council Conclusions concerning the Council Framework Decision on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters

 On 4 October 2005, the Commission forwarded a proposal for a Council Framework Decision on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters ("DPFD") to the Secretary-General of the Council. On 13 December 2005, the Council consulted the Parliament on the proposal. The Parliament delivered its opinion on 27 September 2006.

- 2. The Commission presented its proposal to the meeting of the MDG Mixed Committee on 9 November 2005. The MDG discussed the proposal at length and completed the third reading at its meeting on 15 and 16 November 2006. At the meeting of the Article 36 Committee on 25 and 26 January 2007, the Presidency set out a series of basic points <sup>1</sup> for revising the proposal, with the aim of removing outstanding reservations and making a real improvement in third-pillar data protection. The draft <sup>2</sup> as revised by the Presidency in agreement with the Commission was submitted to the Article 36 Committee at its meeting on 23 March 2007 and was given a first reading by the MDG on 29 and 30 March and on 3 April 2007. The text was revised on the basis of the first reading by the MDG; this revised draft text, dated 24 April 2007, <sup>3</sup> was presented to the Article 36 Committee on 27 April 2007. The European Parliament delivered its opinion regarding the revised draft of 13 March 2007 on 24 May 2007.<sup>4</sup>
- 3. At the meeting of the Art. 36 Committee on 22 May 2007, the Presidency called for a decision on two central issues raised in discussions up to that point: the scope of application and the provisions governing the transfer of data to third countries.<sup>5</sup> The Presidency is of the view that the Member States need to agree on the two issues soon.
- 4. The Presidency plans to present at the JHA Council on 12-13 June 2007 an overview of the current status of consultations on the Council Framework Decision on the protection of personal data <u>as well as draft conclusions.</u>
- 5. COREPER is requested to approve the conclusions attached in the annex and to present them to the JHA Council for their adoption.

## Council Conclusions concerning

## the Council Framework Decision on the protection of personal data processed in the framework of police and judicial co-operation in criminal matters

The Council recognizes the importance of the existence of a comprehensive and coherent set of rules at the level of the European Union concerning the high level of protection of personal data processed in the framework of police and judicial co-operation in criminal matters, as a part of the Union's ever increasing set of regulatory instruments on such co-operation. These rules will <u>build</u> <u>upon</u> the minimum data protection principles set by the Convention of 28 January 1981 for the protection of individuals with regard to automatic processing of personal data and its Additional Protocol of 8 November 2001, and <u>take account of</u> Recommendation (87)15 regulating the use of personal data in the police sector, both adopted in the framework of the Council of Europe.

The Council <u>notes that</u> the European Parliament <u>has</u> rapidly forward<u>ed</u> its opinion on the revised draft <u>of the</u> Council Framework Decision on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters <u>and will examine all solutions</u> suggested by the European Parliament, in the spirit of co-operation that is reflected in the opinion. <u>The Council thanks the Parliament for its co-operation on this issue.</u>

The Council notes the general principles in the annex to the opinion of the European Parliament of 24 May 2007 on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters. The Council <u>will take</u> these principles, <u>where appropriate</u>, into <u>consideration</u>, <u>when drafting</u> the Council Framework Decision on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters.

<u>The Council continues to give priority to the examination of the proposal for a Council Framework</u> Decision on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters, and intends to reach a political agreement on the proposal as soon as possible and at the latest by the end of 2007.
