Reported and recorded uses of TASER

This is the third report on the trial of the extension of the use of TASER to specially trained units from 1st September 2007. The reports attached to this letter detail the figures for the end of quarter 3 on a cumulative basis.

Reports on the use of TASER are broken down into three tables:

- All uses of TASER in England and Wales since introduction in April 2004 up to 31 May 2008 (Table 1).
- TASER use by authorised firearms officers outside of a firearms authority from 20 July 2007 to 31 May 2008 (Table 2).
- 3. TASER use by specially trained units in the first 9 months in the ten trial forces' areas from 1 September 2007 to 31 May 2008 (Table 3).

This report represents a breakdown of TASER usage by specially trained units within the ten forces participating in the current pilot trial.

The forces participating in the trial are Avon and Somerset, Devon and Cornwall, Gwent, Lincolnshire, Merseyside, Metropolitan Police Service, Northamptonshire, Northumbria, North Wales and West Yorkshire.

NB: Not all forces have participated during these whole periods.

The above reports detail the number of uses of TASER – only the highest level of 'use' for each TASER deployment is recorded. The total number of 'incidents' is also reported in the tables to provide continuity with how TASER deployments have previously been recorded by ACPO. The attached tables' principal focus on TASER 'uses' as opposed to TASER 'incidents' is designed to ensure full transparency on TASER deployment as there may be more than one 'use' at an 'incident'.

NB: Direct comparisons between forces should be drawn with caution for the following reasons:

· Not all forces have participated during all periods.

- · The population size and demographic within each force area varies considerably
- Deployment forms are not always received in a timely fashion or chronological order.
- We cannot be certain that historically all forces have recorded TASER usage in the same way, though this has been mitigated by ACPO issuing clear instructions to forces on reporting procedures.
- All figures are based on forms detailing deployments between the stated dates and submitted to HOSDB by 8th July 2008.
