CY has indicated that it complies with the provisions on freezing of property whilst legislative work is ongoing so as to comply with the provisions on freezing of evidence.

The Republic of Cyprus had ratified the Convention on Cybercrime, Budapest, 23.11.2001 with Law (L.22(III)/2004). It is in a process of amending its Law 22(III)/2004, taking into consideration of the Framework Decision.

ES is in process of amending its Criminal Code, the bill is currently being discussed in the Parliament.

PT has indicated that the legislative work is ongoing.

UK has indicated that the implementation of the FD is in process.

This table deals only with implementation of Decision 2005/671/JHA as far as transmission of information to Eurojust is concerned. It is based on the report issued by Eurojust (see 9553/08 RESTREINT UE). The criteria used here to determine whether or not Member States have implemented the Decision is their reply to question "Have your national authorities developed procedures to ensure selection and transmission of information, it is difficult to see how Member States can be considered as having implemented the Decision.
