Subject :	Agreement between the European Union and the United States of America on the processing and transfer of passenger name record (PNR) data by air carriers to the United States Department of Homeland Security (DHS) — Declarations made in accordance with Article 24(5) TEU - State of Play	

- 1. On 23 July 2007, the Council authorised the Presidency to sign the Agreement between the European Union and the United States of America on the processing and transfer of passenger name record (PNR) data by air carriers to the United States Department of Homeland Security (DHS). At the time of the adoption of the Council Decision authorising the Presidency to sign the Agreement, the following Member States indicated that, in order for the Council to conclude this Agreement, they would have to comply with the requirements of their constitutional procedures in accordance with Article 24(5) TEU: BE, CZ, DE, ES, LV, LT, HU, MT, NL, PL and FI (12015/07 JAI 397 USA 48 RELEX 583 AVIATION 135 DATAPROTECT 36).
- 2. The attached table gives an overview of the state of play regarding these procedures.
