Subject: Proposal for a Regulation of the European Parliament and of the Council
on the protection of individuals with regard to the processing of personal
data and on the free movement of such data (General Data Protection
Regulation)

- Presidency debriefing on the outcome of the trilogue on 14 July 2015

Introduction

1. On 14th July 2015, the representatives of the Council, the European Parliament and the Commission discussed in a trilogue on the General Data Protection Regulation the provisions related to Chapter V on transfer of personal data to third countries or international organisations and on the territorial scope of the Regulation. The Council's interventions were based on the Council's General Approach and the discussions that took place in the DAPIX meeting of 1st July 2015 and the JHA Counsellors meeting of 6th July 2015.

The outcome of the trilogue is reflected in the table in annex. Delegations will note that there is a significant amount of convergence between the positions of the European Parliament and the Council. The indications in the fourth column show tentative agreement on individual provisions which are without prejudice to the principle that no individual provision is agreed until agreement is reached on the Regulation as a whole.

2. Delegations are reminded that provisions relating to codes of conduct (articles 38 and 38a) and certification (articles 39 and 39a) will be discussed in relation to Chapter IV.

3. The Presidency, based on the Council's General Approach and the discussions that took place in the DAPIX meeting of 1st July 2015 and the JHA Counsellors meeting of 6th July 2015, tentatively agreed with the European Parliament on the following provisions¹:

- definitions - Articles 4(14), 4(16), 4(17) and 4(21);
- territorial scope – Article 3(2(a)), (3)
- representative of controllers not established in the Union - Article 25 (1), (2) chapeau, (2(a)), (2(c)), (2(d)), (3a), (4);
- transfers with an adequacy decision - Article 41 (1),(2) chapeau, (2(a)), (2(b)), (2(c)), (4) and (5) with the exception of the reference to delegated acts, (5a), (6) and (7); recitals (80), (81), (81a), (81b);
- transfers by way of appropriate safeguards – Article 42(1), (2) chapeau, (2(a)), (3), (4);
- transfers by way of binding corporate rules - Article 43 (1), [(1(a))], (1(b)), (1(c)), (2) chapeau, (2(a)), (2(b)), (2(c)), [(2(d))], [(2(e))], (2(f)), [(2(g))], (2(h)), (2(hh)), (2(i)), (2(j)), (2(k)), (2(l)) and (2(m)), (2a), (3), (4); recital (85);
- derogations for specific situations - Article 44 (1) chapeau, (1(a)), (1(b)), (1(c)), (1(d)), (1(e)), (1(f)) and (1(g)), (2), (3), (4), (5) and (5a); recital (87);
- international cooperation for the protection of personal data - Article 45(1), (1(a)), (1(b)), (1(c)), (1(d)), (2);
- Recitals (19), (22), (78), (79), (86), (91).

¹ Tentative agreement of a provision by the trilogue is without prejudice to possible future changes in case such a provision contains elements other than those related to the international dimension (marked in brackets) as well as changes to ensure the overall coherence of the General data Protection Regulation.

4. With regard to the role of the European Data Protection Board, the European Parliament accepts to move the references included in Article 41(2a) and Article 44(7) to article 66 for the sake of simplification.
5. With regard to transfers by way of appropriate safeguards:
- The European Parliament agreed to include Article 42 (2(oa)) concerning legally binding and enforceable instruments between public authorities and bodies in the compromise text. In addition, the European Parliament accepted to include Article 42 (2a) concerning administrative arrangements between public authorities or bodies, as contained in the Council’s General Approach, on the condition that the words “*in particular enforceable and effective data subjects’ rights*” are added at the end of subparagraph (b). Recital (89) is aligned accordingly.
 - The European Parliament agreed to include Article 42 (2(b)) concerning standard data protection clauses adopted by the Commission, as contained in the Council’s General Approach, with the clarification to replace the term “*adopted*” by “*approved*” in Article 42(2(c)) concerning standard data protection clauses adopted by supervisory authority and “*approved*” by the Commission. Recital (83) is aligned accordingly.
6. With regard to Article 3, the co-legislators tentatively agreed to:
- Include the reference “*whether the processing takes place in the Union or not*” at the end of the paragraph (1);
 - Include the terms “*or processor*” in the chapeau of paragraph (2), as well as to replace the term “*residing*” by “*who are*”; the recitals (20) and (21) are aligned accordingly;
 - Maintain the Council’s General Approach in paragraph (2)(b), making reference to the notion of “*the monitoring of their behavior as far as their behaviour takes place within the European Union*”; the recitals (20) and (21) are aligned accordingly.
7. With the exception of the words “*which shall be supplied without undue delay*”, the co-legislators agreed to include the content of Article 45a (new) concerning a report by the Commission into Article 90.

8. The following issues on which there were divergent views between the co-legislators have been examined together with a view of seeking a package compromise:

- General principles for transfers - Article 40
- Implementing/delegated acts for adequacy decisions - Article 41(3), (4a) and (5); align Article 42(1), recital (82);
- Grandfather clause/sunset clause for existing adequacy decisions and existing authorisations by Member States or DPAs - Article 41(3a), Article 41 (8) and Article 42(5), (5b) ;
- Derogations for specific situations: transfer in case of legitimate interest controller - Article 44(1)(h) and (6); recital (88) and (89).

The Presidency signalled openness as regards inclusion of Article 40 relating to general principles for transfers depending on the European Parliament's flexibility on other points of divergence.

As regards the implementing/delegated acts for adequacy decisions, the European Parliament could accept implementing acts subject to the inclusion of a provision foreseeing its involvement in the [review process/elaboration] of existing adequacy decisions. The European Parliament also wants future adequacy decisions to contain a general monitoring and periodical review clause.

The wording will be carefully scrutinised in order to ensure that the European Parliament is not granted any other power than what is provided for in Article 11 of Regulation N° 182/2011.

As regards the implementing/delegated acts for new adequacy decisions, and as regards the grandfather clause/sunset clause for existing adequacy decisions, the European Parliament could accept implementing acts, and a grandfathering clause instead of a sunset clause, subject to:

- (i) the introduction of a periodic review clause in all new adequacy decisions within a determined timeframe (the European Parliament proposed 3 years);

- (ii) a greater role of the European Parliament as regards the follow-up of the review. The wording will be carefully scrutinised in order to ensure that the European Parliament is not granted any other power than what is provided for in Article 11 of Regulation N° 182/2011; and
- (iii) an evaluation of existing adequacy decisions as part of the reporting obligation of the Commission in Article 90.

As regards the grandfather clause/sunset clause for existing adequacy decisions, the European Parliament could accept the replacement of a sunset clause by a grandfather clause subject to a mandatory review by the Commission within a determined timeframe (the European Parliament proposed 3 years).

As regards the grandfather clause/sunset clause for existing authorisations by Member States or DPAs, the European Parliament could accept the replacement of a sunset clause by a grandfather clause subject to a review by the Member States or DPAs, “*if necessary*”.

As regards derogations for specific situations and a transfer in case of legitimate interests of a controller, the European Parliament could envisage to accept this derogation in Article 44(1)(h) and (6) only under the condition of further framing and specifications, in particular:

- the limited number of data subjects concerned;
- as a last resort, in particular if no other derogation in Article 44(1) points (a) to (g) is applicable for the derogatory transfer (residual character);
- information of the transfer to the supervisory authority;
- information of the transfer to the data subject.

9. Concerning Article 43a (new), the European Parliament shows flexibility to limit this Article to the idea contained in the first paragraph of its proposal referring to the respect of international agreements in case of a transfer or disclosure requested by a judicial or administrative authority of a third country. Subject to redrafting and notwithstanding the general application of chapter V to international transfers, the Presidency suggests accepting this compromise proposal.

10. Taking into account the flexibility shown by the European Parliament on the above mentioned issues, subject to alignment of the relevant recitals, and recalling that nothing is agreed until everything is agreed, the Presidency considers this package as an acceptable compromise for Council.




