#### AWARD DECISION

# Internal Security Fund Police 2015 Call for proposals HOME/2015/ISFP/AG/TDFX "Transnational initiatives to fight trafficking in drugs and firearms"

THE EUROPEAN COMMISSION (hereinafter referred to as "the Commission")

Having regard to Regulation (EU, Euratom) No 966/2012 of 25 October 2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union<sup>1</sup> (hereinafter referred to as the 'Financial Regulation'), and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union<sup>2</sup> (hereinafter referred to as the 'Rules of Application'), and in particular Article 204 thereof,

Having regard to the Regulation (EU) No 513/2014 of the European Parliament and of the Council of 16 April 2014 establishing, as part of the Internal Security Fund, the instrument for financial support for police cooperation, preventing and combating crime, and crisis management and repealing Council Decision 2007/125/JHA<sup>3</sup>,

Having regard to the Regulation (EU) No 514/2014 of the European Parliament and of the Council of 16 April 2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management<sup>4</sup>,

#### Whereas:

1. The Commission adopted an annual work programme and financing decision for 2015 on 8 June 2015 (C(2015) 3765 final). The annual work programme contains the provision to award action grants following a Call for proposals;

- A Call for proposals for action grants on the "Transnational initiatives to fight trafficking in drugs and firearms" (HOME/2015/ISFP/AG/TDFX) was published on 23 September 2015. It establishes the objectives and priorities and the admissibility, eligibility, exclusion, selection and award criteria;
- 3. An Evaluation Committee was appointed on 11 December 2015 pursuant to Article 204(1) of the Rules of Application;
- 4. An evaluation was carried out pursuant to Articles 133(1) and (2) of the Financial Regulation and 204 of the Rules of Application.

### HAS DECIDED AS FOLLOWS:

# Article 1 - Awarded Proposals

The proposals listed in Annex I to this Decision shall be awarded a grant under the Call for proposals on "Transnational initiatives to fight trafficking in drugs and firearms", up to the maximum amount indicated in that Annex. The overall amount of financing provided is EUR 3 675 820,26.

## Article 2 - Rejected Proposals

The proposals listed in Annex II to this Decision are rejected under the Call for proposals on "Transnational initiatives to fight trafficking in drugs and firearms".
