3. REPORT BY THE HIGH-LEVEL GROUP ON ORGANIZED CRIME TO THE EUROPEAN

COUNCIL

Docs 7482/2/97 JAI 15 REV 2 7421/97 JAI 14

The Presidency explained that the report of the High Level Group would constitute the basis for a

European response to fight organized crime. It would be submitted for approval to the European Council

and the Council (JHA) would need to take account of the report in the future implementation of the

multi-annual work programme. Such implementation would also take account of the conclusions of the

Dublin European Council.

Delegations warmly congratulated the Presidency for the excellent work which had been carried out by

the High Level Group. In general, the report constitutes a good basis for future work to fight organized

crime in the Union.

Certain amendments to the conclusions of the Council were proposed and accepted (see doc. 7482/3/97

JAI 15 REV 3).

The Italian Minister of Justice reminded his colleagues of the importance of being able to use structural

funds in regions which are particularly touched by organized crime and of preventing offshore

institutions from being used by organized crime.

The United Kingdom Minister of State reminded her colleagues that the United Kingdom had accepted the report of the High Level Group on the understanding that the conspiracy offence in the United Kingdom would be covered by the participation offence foreseen in political guideline No 1 of the Plan of Action.

The French Minister reminded his colleagues of the importance of implementing in particular the extradition conventions, the Joint Actions on Racism and Xenophobia, on trafficking in human beings and sexual exploitation and on approximation of drugs legislation.
