#### **Foreword**

The **rapid and full operationalisation** of the European Border and Coast Guard (EBCG) 2.0 Regulation is a top priority for the EU.

The **advanced preparatory process** starting before the new Regulation's entry into force (June to November 2019) is a pre-requisite for its successful and timely implementation, especially to ensure the full readiness of the EBCG standing corps for deployment as of 1 January 2021 and guaranteeing the effective use of the substantial budget earmarked to build the Agency's own technical capabilities.

This process must involve all the relevant stakeholders (the European Border and Coast Guard Agency, the Commission and Member States) in a transparent and cooperative manner starting from now onwards.

In order to ensure transparency and effective monitoring of the progress as well as the full accountability towards the EU Institutions, the Commission services together with the European Border and Coast Guard Agency have developed this **Roadmap** covering all the main novelties brought by the new Regulation. The Roadmap also identifies the priorities for implementation among and makes the linkages between all those novelties.

The role of the Agency's **Management Board** will be key in agreeing and adopting a series of implementing measures as well as in providing strategic steering. For that reasons, the Management Board will hold an extraordinary meeting entirely dedicated to the strategic preparations for the operationalisation of the new Regulation on 2-3 October 2019.

The effective and constructive **engagement of Member States** not only at political, but also at operational and technical level to work closely with the Agency and Commission to implement all the requirements of the new Regulation in the coming months, is essential for the successful implementation of the new Regulation and the achievement of this historical change.

The structured cooperation between the EBCG Agency and the Commission will be the key element ensuring the smooth implementation of the main activities listed and their progress in accordance with the Roadmap.

### Explanation of the Roadmap

The individual tasks have been regrouped either by chapter corresponding to key policy priorities or by thematic functions (some tasks refer to both), with subchapters and individual numbering.

The first chapter describes the horizontal tasks, covering activities that are not directly related to an article of the Regulation but which are deemed indispensable to initiate key aspects of the implementation.

, reference is made to the relevant article/paragraph. Tasks follow in a logical sequence. However, when completion of another task is a prerequisite or is linked, this tasks is cross-referred. The timelines are either indicative or derive directly or indirectly from the Regulation. The lead actors are either the Member States (MS), the Commission (COM), the EBCG Agency's Management Board (MB), the Executive Director of the EBCG Agency (ED), the Agency's Fundamental Right Officer (FRO). Whenever this is not clearly specified or depends upon a decision made via a precedent task, a general reference is made to the Agency (EBCGA).

Travel restrictions also negatively affected/delayed the performance of physical aptitude tests and of pre-employment medical checks. Further delays were caused by the inability of the Brussels Medical Service to perform the medical checks which made it necessary for the Agency to launch an additional procurement for the service to be ensured by an alternative external contractor  Overall, following the intake of the first two batches of European Border and Coast Guard Officers that took place in June and in October 2020, Frontex will have on board 420 standing corps Category 1 as of 1 January 2021 (255 ready for deployment in January 2021, 165 still under training, and ready for deployment in May 2021).  The third group of the candidates completed interviews and physical aptitude tests in September 2020.
