- Biometric categorisation in (art. 5.1 ba)
- Removing the exceptions for Law Enforcement in the use of 'real-time' remote biometric identification systems in publicly accessible spaces (art 5.1 d, 5.2, 5.3, 5.4)
- AI systems for individual risk assessment of natural persons or groups, making recidivism estimates, predicting offence occurrence (art. 5.1 da)
- AI systems that create or expand facial recognition databases through the untargeted scraping of facial images (art. 5.1 db)
- Categorising motion recognition systems as High-Risk (Annex III under 1c) and changes in Annex III under 6, related to new prohibitions.

And also have a look at recent developments with respect to regulation of generative AI (like use of LLM) and national position in EU countries on these proposed amendments
