1. Bilateral engagement and support to the preparation of the National Implementation Plans

- **Baseline for needs assessment** shared with Member States on 26 June 2024
- **Bilateral meetings** at senior & technical level with each Member State
- **Replies** received by almost all Member States
- **Finalisation of needs assessment** ongoing, to be shared with Member States early October (covers all building blocks, including recommendations on national priorities)
- **Draft National Implementation Plans** expected by October

2. Horizontal support and milestones (1)

Eurodac

- **Critical Interface Control Document (ICD)** to be shared with Member States at beginning of October with full delivery planned for mid-December.

Borders

- **Implementing Act** setting out the **adequate capacity** adopted in August
- Models for **capacity needs** for the screening and for the border procedures (Commission and EUAA with Frontex support)
- Model **workflows** on Screening & Border Procedure (Commission and EUAA) – Q4 2024
- **Blueprint** for Screening/Asylum Border Procedure Centre (Commission and EUAA) – Q4 2024/Q1 2025
- **Draft guidance document on Screening** (discussed within Schengen Borders Code contact committee on 13 September)
- **Fundamental Rights Agency guidelines** on the Monitoring of Fundamental Rights Independent Mechanism

2. Horizontal support and milestones (2)

Other deliverables

- The « **dry run** » **exercise** (simulation of the Annual Report)
- Template for **National Contingency Plans** under the Reception Conditions Directive (EUAA) and manual
- Guidance on **alternatives to detention** (EUAA/Frontex) - being finalised
- **Information template** (Asylum Migration Management Regulation, Asylum Procedure Regulation and Reception Conditions Directive)
- Implementing Act setting up the **Template for the national asylum and migration management strategies** (Asylum and Migration Management Regulation)
