- ² There is no obligation for the Member States to inform the Council General Secretariat about the national measures of implementation of the Eurojust Decision. However, pursuant to Article 2 of the Joint Action 97/827/JHA of 5 December 1997, the sixth round of mutual evaluations devoted to the practical implementation and operation of the Decisions on Eurojust and the European Judicial Network in criminal matters is currently ongoing. Relevant information on the state of implementation of the Eurojust decision will be available in the individual country reports, which will be published regularly.
- ³ CY has indicated that it has fully implemented the FD in 2010, however as the translation of the document in question is ongoing the copy of this legislation has not yet been sent to the GSC, but will be sent asap.
- ⁴ EL has indicated in 2006 that implementation of the FD is in process (under elaboration of a Special Law Drafting Committee).

- ¹⁰ This table deals only with implementation of Decision 2005/671/JHA as far as transmission of information to Eurojust is concerned. The criteria used here to determine whether or not Member States have implemented the Decision is their reply to question "Have your national authorities developed procedures to ensure selection and transmission of information to Eurojust?". Without any procedure to ensure selection and transmission of information, it is difficult to see how Member States can be considered as having implemented the Decision.
