Subject:	Proposal for a Regulation of the European Parliament and of the Council establishing rules for the surveillance of the external sea borders in the context of operational cooperation coordinated by the European Agency for the Management of Operational Cooperation at the External Borders of the Member States of the European Union

---

Following the meeting of JHA Counsellors/Mixed Committee on 27 January 2014 on the basis of doc. 5612/14, a third informal trilogue with the European Parliament and the Commission took place on 29 January 2014.

The four-column table resulting from the above meeting (also including some subsequent to this trilogue compromise proposals from the Presidency) is set out in the Annex to this Note.

Significant progress was achieved at the aforementioned informal trilogue. The Presidency considers that the compromise tentatively agreed upon so far on most of the outstanding issues in the context of this proposal caters for the most important concerns of the delegations.

In particular, provisional agreement has been reached, among other issues, on the search and rescue provisions, on the issues related to disembarkation (with the exception of Parliament's amendment 48 regarding information on where disembarkation will take place), and on the principle of solidarity.

Furthermore, significant progress has been made in relation to the interception provisions. However, no tentative compromise has been reached so far in relation to: i) the special medical needs of the intercepted persons, ii) the suggestion of the Parliament to transfer point (c) of Articles 6(1) and 7(1) regarding identification measures under the list of possible enforcement measures, and iii) the warning and ordering of the vessel, which is on the high seas not to enter the territorial sea, provided for under Art. 7(1a)(b).

Significant progress was also made regarding the issues related to the principle of non-refoulement. A tentative compromise is yet to be reached on the issues provided for under Art. 4(3) as regards identification of the intercepted persons, assessment of their personal situation and information on their disembarkation, as well as on the possibility of exchange of personal data with third countries, pursuant to Art. 4(4a).

The Presidency is of the opinion that the above outstanding issues could be solved as part of an overall compromise with the European Parliament on the basis of the draft suggestions it submits in the present document to the JHA Counsellors/Mixed Committee for their meeting on 3 February 2014.

Furthermore, the Presidency intends to submit the item to the Permanent Representatives Committee on 5 February 2014, with a view to obtaining an amended mandate for concluding an overall compromise agreement with the co-legislator at the next informal trilogue, scheduled for 11 February 2014.
