Thank you for your recent request under the Freedom of Information Act 2000 which was received in this office on the 18<sup>th</sup> July 2013.

Section 1 of the Freedom of Information Act 2000 (FOIA) places two duties on public authorities. Unless exemptions apply, the first duty at, Section 1(1) (a), is to confirm or deny whether the information specified in a request is held. The second duty at, Section 1 (1) (b), is to disclose information that has been confirmed as being held.

Under the provisions of those sections of FOIA, I can confirm that information you requested is held by Gwent Police for the below questions so we are able to comply with your request to supply information.

The information that you are seeking is in relation to the following:

Q1. Has your force used (in a trial or otherwise) or considered using unmanned aerial vehicles (UAVs)?

I would like this information cover the period 1 July 2009 to 30 June 2013.

Additionally, Gwent Police can neither confirm nor deny that it holds any other information relevant to your request by virtue of the following exemption:

Section 23(5) Information relating to the Security bodies;

Section 23 is an absolute class-based exemption and therefore there is no requirement to conduct a harm or public interest test.

The Freedom of Information Act is a public disclosure regime, not a private regime. Any information disclosed under the Act is thereafter deemed to be in the public domain, and therefore freely available to the general public and will be published on the Gwent Police website.

I hope this information is satisfactory to your request however, should you feel dissatisfied with this response or the way in which your request was handled, I have attached the Gwent Police FOI Appeals Procedure for your information.
